

On motion by Lindel Toups, seconded by John Arnold, the following resolution was introduced and adopted;

RESOLUTION NO. 14-071

RESOLUTION APPROVING CHANGE ORDER NO. 2 FOR THE PROJECT ENTITLED HURRICANE ISAAC RECREATION FACILITY REPAIRS TO ADD TEN (10) CALENDAR DAYS TO THE CONTRACT TIME AND INCREASING THE CONTRACT PRICE BY \$4,750.00 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, this Change Order is being presented to add ten (10) calendar days to the contract time and increasing the contract price by \$4,750.00 due to replacing a light bracket on pole P2, replacing fence around dugout D4, awning repair A4, and bench repair at Golden Meadow Park; and

WHEREAS, ten (10) calendar days will be added to the contract time and the contract price will be increased by \$4,750.00 for a new contract price totaling \$97,142.35; and

WHEREAS, it is the recommendation of J. Wayne Plaisance, Inc. and this Administration that said Change Order be accepted; and

WHEREAS, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

WHEREAS, it is recommended by the Administration of Lafourche Parish Government that the Council approves Change Order No. 2 for the project entitled Hurricane Isaac Recreation Facility Repairs to add ten (10) calendar days and increasing the contract price by \$4,750.00 and authorizes the Parish President to sign, execute and administer said change order and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on March 25, 2014, and does hereby approve Change Order No. 2 to the project entitled Hurricane Isaac Recreation Facility Repairs to add ten (10) calendar days and increasing the contract price by \$4,750.00 and authorizes the Parish President to sign, execute and administer said change order and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to J. Wayne Plaisance, Inc.
