RESOLUTION APPROVING THE PURCHASE OF TWO (2) TRAILER MOUNTED SEWER JETTERS FOR THE DEPARTMENT OF PUBLIC WORKS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the Department of Public Works is in need of two (2) trailer mounted sewer jettors for a total of \$109,280.00; and

WHEREAS, Lafourche Parish Government will be participating in cooperative purchasing with the City of Alexandria pursuant to LA. R.S. 39:1701- R.S. 39:1709; and

WHEREAS, the funding for the purchase of two (2) trailer mounted sewer jettors will be as follows:

- \$54,640.00 from RSTD-A Funds
- \$25,560.00 from LGAP State Grant
- \$25,560.00 from Royalty Funds (per Ordinance No. 5393)
- \$3,520.00 from RSTD-2 Sales Tax Funds

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council does hereby approve the purchase of two (2) trailer mounted sewer jettors for the Department of Public Works and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on March 25, 2014, and does hereby approve the purchase of two (2) trailer mounted sewer jettors for the Department of Public Works and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
