

On motion by JoeFertitta, seconded by Phillip Gouaux, the following resolution was introduced and adopted;

RESOLUTION NO. 14-074

A RESOLUTION APPROVING AN AGREEMENT BETWEEN PICCIOLA & ASSOCIATES, INC. AND LAFOURCHE PARISH GOVERNMENT FOR ENGINEERING SERVICES FOR REPAIRS TO THE GALLIANO PONTOON BRIDGE IN THE AMOUNT OF \$5,288.50 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the guard rail and concrete on the Galliano Pontoon Bridge were damaged during a vehicle accident; and

WHEREAS, the repairs to the guard rail and concrete require structural engineering design; and

WHEREAS, Picciola & Associates, Inc. submitted an agreement for engineering services for a lump sum fee of \$5,288.50; and

WHEREAS, the funding will come from the RSTD-2 Funds; and

WHEREAS, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman District 9; and

WHEREAS, it is recommended by the Administration of Lafourche Parish Government that the Council does hereby approve the agreement between Picciola & Associates, Inc. and Lafourche Parish Government for Engineering Services for repairs to the Galliano Pontoon Bridge in the amount of \$5,288.50 and authorizing the Parish President to sign, execute and administer said agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on March 25, 2014, and does hereby approve agreement between Picciola & Associates, Inc. and Lafourche Parish Government for Engineering Services for repairs to the Galliano Pontoon Bridge in the amount of \$5,288.50 and authorizing the Parish President to sign, execute and administer said agreement and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Picciola & Associates, P.O. Box 687, Cut Off, LA 70345, Attention: Joseph Picciola II, P.E., P.L.S., Lafourche Parish Government Department of Public Works, Department of Finance, and the Office of the Parish Administrator.
