**RESOLUTION NO. 14-084**

**RESOLUTION REQUESTING THE LAFOURCHE PARISH COUNCIL TO SUPPORT LEGISLATION TO BE INTRODUCED BY LOUISIANA REPRESENTATIVE HELENA MORENO REGARDING HOUSE BILLS 747, 748, 749, 750 AND 753 (ATTACHED) AS IT PERTAINS TO DOMESTIC ABUSE.**

**WHEREAS**, it is the duty upon oath that the Governing Authority and State Officials address concerns dealing with the general health, safety and welfare of the citizens and said resolution satisfies this criteria; and

**WHEREAS**, at the request of United Way of Southeast Louisiana (UWSELA), Representative Helena Moreno will introduce legislation to assist and protect victims of domestic abuse; and

**WHEREAS**, these bills will be heard before the House Civil Law and Procedure Committee and the House Administration of Criminal Justice Committee on March 24, 2014 and March 26, 2014 respectively; therefore

**BE IT RESOLVED**, by the Lafourche Parish Council, which convened in regular session on March 25, 2014, that it does hereby request the Lafourche Parish Council to support legislation to be introduced by Louisiana Representative Helena Moreno regarding House Bills 747, 748, 749, 750 and 753 (attached) as it pertains to domestic abuse.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to Representative Helena Moreno; Ms. Charmaine Caccioppi, Executive Vice President and Chief Operating Officer for United Way of Southeast Louisiana; and the Office of the Parish Administrator.
