A RESOLUTION ACCEPTING THE QUOTE FROM GOLDEN RANCH AVIATION FOR AERIAL SPRAYING OF THE CANALS AND RESERVOIRS THROUGHOUT LAFOURCHE PARISH AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER AN AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, three (3) quotes were requested and three (3) responded for aerial spraying of canals and reservoirs throughout the Parish; and

WHEREAS, the lowest quote was received from Golden Ranch Aviation in which the fees will consist of the following:

**including chemicals, personnel and equipment to ensure precise coverage and control of invasive vegetation*

WHEREAS, Golden Ranch Aviation will guarantee a 90% kill on said vegetation; and

WHEREAS, all field office supervisors submitted areas that are in need of spraying; and

WHEREAS, funds are budgeted in the 2014 Drainage Fund; and

WHEREAS, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve the quote from Golden Ranch Aviation for aerial spraying of the canals and reservoirs throughout Lafourche Parish and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on April 8, 2014, and does hereby accept the quote from Golden Ranch Aviation for aerial spraying of the canals and reservoirs throughout Lafourche Parish and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Golden Ranch Aviation, P. O. Box 280, Raceland, LA 70394; Lafourche Parish Government Department of Public Works, Finance Department, and the Office of the Parish Administrator.
