RESOLUTION APPROVING THE LOW QUOTE OF LA CONTRACTING ENTERPRISES LLC FOR REPAIRS TO THE PARR PUMP STATION IN THE AMOUNT OF \$72,470.00 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, repairs to the Parr Pump Station is necessary in order to secure foundation of the pump station and adjacent property; and

WHEREAS, (3) three quotes were requested as listed below with LA Contracting Enterprises, LLC having the lowest quote; and

LA Contracting Enterprises LLC	\$ 72,470.00
JPL Construction, LLC	\$ 79,500.00
Tidewater Docks Inc.	\$ 95,500.00

WHEREAS, funding will come from the drainage maintenance fund under repair and maintenance of pumps; and

WHEREAS, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve the low quote of LA Contracting Enterprises LLC for repairs to the Parr Pump Station in the amount of \$72,470.00 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on April 8, 2014, and does hereby approve the low quote from LA Contracting Enterprises LLC for repairs to the Parr Pump Station in the amount of \$72,470.00 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
