RESOLUTION APPROVING THE LOW QUOTE OF SEALEVEL CONSTRUCTION, INC. FOR REPAIRS TO THE MORVANT PUMP STATION IN THE AMOUNT OF \$85,550.00 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, repairs to the Morvant Pump Station is necessary in order to repair flap gates; and

WHEREAS, (3) three quotes were requested as listed below with Sealevel Construction, Inc. having the lowest quote; and

1.	Sealevel Construction, Inc.	\$85,550.00
2.	LA Contracting Enterprises, LLC	\$112,250.00
3.	Low Land Construction Co., Inc.	\$149,650.00

WHEREAS, funding will come from the drainage maintenance fund under repair and maintenance of pumps; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve the low quote of Sealevel Construction, Inc. for repairs to the Morvant Pump Station in the amount of \$85,550.00 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on April 8, 2014, and does hereby approve the low quote of Sealevel Construction, Inc. for repairs to the Morvant Pump Station in the amount of \$85,550.00 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
