RESOLUTION NO. 14-101

RESOLUTION APPROVING CHANGE ORDER NO. 1 FOR THE PROJECT ENTITLED DES ALLEMANDS BREAKWATER BULKHEAD INCREASING THE CONTRACT PRICE BY \$9,601.12 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Lafourche Parish Government has received a funding allocation from the Louisiana Office of Community Development- Disaster Recovery Unit for the Des Allemands Breakwater Bulkhead Project under the Hurricanes Gustav/Ike Community Development Block Grant Parish- Implemented Recovery Program; and

WHEREAS, said Change Order No. 1 is to balance quantities and add eight new pay items; and

WHEREAS, said Change Order No. 1 will increase the total amount of contract by \$9,601.12 for a new contract price totaling \$2,960,435.12; and

WHEREAS, said Change Order No. 1 from Cycle Construction, LLC, Contractor, has been reviewed by the Project Engineer, All South Consulting Engineers, LLC and Louisiana Solutions, LLC, and the Project Engineer, All South Consulting Engineers, LLC recommended that Change Order No. 1 be accepted and approved; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte Councilman, District 2; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve Change Order No. 1 for the project entitled Des Allemands Breakwater Bulkhead to increase the contract price by \$9,601.12 and authorizing the Parish President to sign, execute and administer said change order and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on April 22, 2014, and does hereby approve Change Order No. 1 for the project entitled Des Allemands Breakwater Bulkhead to increase the contract price by \$9,601.12 and authorizing the Parish President to sign, execute and administer said change order and any and all relevant documents.
