### PROPOSED ORDINANCE

The following Ordinance, having been previously introduced and published, was offered for final adoption by Mr. John Arnold, seconded by Mr. Jerry LaFont.

### ORDINANCE NO. 5411

#### **AN ORDINANCE ESTABLISHING THE 2014 SALARIES OF THE COUNCIL CLERK, LEGISLATIVE INTERNAL AUDITOR AND LEGISLATIVE INTERNAL AUDITOR CLERK AND ESTABLISHING PROCEDURE FOR INCLUSION IN THE ANNUAL PROPOSED OPERATING, MAINTENANCE AND CAPITAL BUDGETS.**

**BE IT ORDAINED**, by the Lafourche Parish Council, which convened in Regular Session on January 14, 2014, that:

**SECTION 1. WHEREAS**, said Ordinance does hereby establish the 2014 salaries of the Council Clerk, Legislative Internal Auditor and Legislative Internal Auditor Clerk and establishes the procedure for inclusion in the annual proposed Operating, Maintenance and Capital Budgets.

**SECTION 2. WHEREAS**, the Council desires to establish a stable process for inclusion of the salaries and positions of Council Clerk, Legislative Internal Auditor and Legislative Internal Auditor Clerk in all future annual Proposed Operating, Maintenance and Capital Budgets, and

**SECTION 3. WHEREAS**, the Legislative Internal Auditor and Legislative Internal Auditor Clerk positions and salaries were not included in the initial 2014 Proposed Operating, Maintenance and Capital Budgets, and

**SECTION 4. WHEREAS**, the Council did amend the 2014 Proposed Operating, Maintenance and Capital Budgets to include the positions and funding for wages and benefits for the positions of Legislative Internal Auditor and Legislative Internal Auditor Clerk, and

**SECTION 5. WHEREAS**, the Council desires to set the annual 2014 salary of the Council Clerk at \$64,662.00, Legislative Internal Auditor at \$66,523.00 and the Legislative Internal Auditor Clerk at \$34,240.00, and

**SECTION 6. WHEREAS**, the Council wishes to include all "EXEMPT" Legislative employees in future Proposed Operating, Maintenance and Capital Budgets with salaries set as follows; the annual salaries for the 2015 Proposed Operating, Maintenance and Capital Budgets shall be included at the 2014 salary set by the most recent Ordinance, plus a Cost of Living Adjustment (COLA) similar to that established in the Civil Service Guidelines, plus any merit or annual increase as recommended by the Council Chairman or majority (5) vote of the Council, forwarded to Administration in a timely fashion for inclusion in the Proposed Operating, Maintenance and Capital Budgets with subsequent years salaries determined in the same fashion, and

**SECTION 7. WHEREAS**, the Council wishes the annual salaries of the Council Clerk, Legislative Internal Auditor and Legislative Internal Auditor Clerk determined by this Ordinance to have an effective date of January 1, 2014 and replace any prior Ordinance.

**SECTION 8.** If any section, clause, paragraph, provision or portion of these regulations shall be held invalid by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of these regulations.

**SECTION 9.** All Ordinances or parts of Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

**SECTION 10.** This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

**SECTION 11.** This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
