

The following ordinance was introduced by Mr. Aaron Caillouet in regular session convened on February 11, 2014.

PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Aaron Caillouet, seconded by Mr. Joe Fertitta.

ORDINANCE NO. 5422

ORDINANCE PROVIDING FOR A 2013 SUPPLEMENTAL APPROPRIATION (13-044) WITHIN THE 2013 OPERATIONS AND MAINTENANCE BUDGET, TO CARRY FORWARD THE 2013 BUDGET FOR DRU CODE ENFORCEMENT; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID TRANSACTIONS AS PROVIDED FOR BY ARTICLE VI OF THE LAFOURCHE PARISH HOME RULE CHARTER.

WHEREAS, the DRU Code Enforcement was awarded in 2011 through federal funds in the amount of \$309,186.85 that cover salaries and benefits for code enforcement in the Permitting and Planning Department; and

WHEREAS, in 2012 \$103,739.38 was expended and the remaining \$205,447.47 should be carried over to 2013; and

WHEREAS, this ordinance was sponsored for Administration by Mr. Aaron Caillouet, Councilman, District 3; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve a 2013 Supplemental Appropriation (13-044) within the 2013 Operations and Maintenance Budget, to carry forward the 2013 Budget for DRU Code Enforcement; and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter.

THEREFORE, BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on February 25, 2014, and hereby approves a 2013 Supplemental Appropriation (13-044) within the 2013 Operations and Maintenance Budget, to carry forward the 2013 Budget for DRU Code Enforcement; and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter; and

BE IF FURTHER ORDAINED, that:

SECTION 1. A Supplemental Appropriation of the 2013 Operations and Maintenance Budget is hereby approved as follows:

FUND 001 - GENERAL FUND

To carry forward DRU Code Enforcement:

1. An increase in INTERGOVERNMENTAL REVENUE in the amount of \$161,902.86
2. An increase in SALARIES & WAGES \$25,354.22
3. An increase in EMPLOYEE BENEFITS \$21,500.13
4. An increase in OTHER SERVICES \$2,059.97

SECTION 2. If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

SECTION 3. All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 4. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 5. A certified copy of this ordinance shall be forwarded to Lafourche Parish Government: Department of Finance, Department of Public Works, Department of Planning and Permitting, and the Office of the Parish Administrator.

SECTION 6. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
