

The following ordinance was introduced by Mr. Lindel Toups in regular session convened on February 11, 2014.

PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Lindel Toups, seconded by Mr. Mike Delatte.

ORDINANCE NO. 5427

ORDINANCE PROVIDING FOR A 2013 SUPPLEMENTAL APPROPRIATION (13-046) WITHIN THE 2013 OPERATIONS AND MAINTENANCE BUDGET AND CAPITAL BUDGET, TO CORRECT THE ORIGINAL AMOUNT AWARDED FOR COMPANY CANAL, PHASE I, FROM DRAINAGE DISTRICT NO. 1 AND LAFOURCHE PARISH GOVERNMENT'S SHARE; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID TRANSACTIONS AS PROVIDED FOR BY ARTICLE VI OF THE LAFOURCHE PARISH HOME RULE CHARTER.

WHEREAS, the Supplement is to correct the original amount awarded for Company Canal, Phase 1, from Drainage District No. 1 of \$1,141,815.79 and the Parish share of \$86,944.00; and

WHEREAS, the funding of \$86,944.00 will be transferred from Royalty; and

WHEREAS, this ordinance was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve a 2013 Supplemental Appropriation (13-046) within the 2013 Operations and Maintenance Budget and Capital Budget, to correct the original amount awarded for Company Canal, Phase I, from Drainage District No. 1 and Lafourche Parish Government's share; and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter.

THEREFORE BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on February 25, 2014, and hereby approves a 2013 Supplemental Appropriation (13-046) within the 2013 Operations and Maintenance Budget and Capital Budget, to correct the original amount awarded for Company Canal, Phase I, from Drainage District No. 1 and Lafourche Parish Government's share; and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter; and

BE IF FURTHER ORDAINED, that:

SECTION 1. A Supplemental Appropriation of the 2013 Operations and Maintenance Budget is hereby approved as follows:

FUND 104 - DRAINAGE FUND

To cover the cost of Company Canal, Phase 1:

1. An increase in INTERGOVERNMENTAL REVENUE in the amount of \$1,141,815.79
2. An increase in OTHER REVENUE \$86,944.00
3. An increase in MISCELLANEOUS \$1,228,759.79

FUND 108 - ROYALTY FUND

To cover the cost of Company Canal Phase 1:

1. An increase in MISCELLANEOUS in the amount of \$86,944.00

SECTION 2. A Supplemental Appropriation of the 2013 Capital Budget is hereby approved as follows:

FUND 299 - CAPITAL PROJECTS

To cover cost of Company Canal Phase 1:

1. An increase in OTHER REVENUE in the amount of \$1,228,759.79
2. An increase in CAPITAL OUTLAY in the amount of \$1,228,759.79

SECTION 3. If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

SECTION 4. All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 5. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 6. A certified copy of this ordinance shall be forwarded to Lafourche Parish Government: Department of Finance, Department of Public Works, Department of Grants and Economic Development, and the Office of the Parish Administrator.

SECTION 7. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
