

The following ordinance was introduced by Mr. Daniel Lorraine in regular session convened on February 25, 2014.

PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Jerry LaFont, seconded by Mr. Lindel Toups.

**ORDINANCE NO. 5432**

**ORDINANCE PROVIDING FOR A 2014 SUPPLEMENTAL APPROPRIATION (14-005) WITHIN THE 2014 OPERATIONS AND MAINTENANCE BUDGET TO SUPPLEMENT HEAD START WITH A DONATION FROM E.D. WHITE CATHOLIC HIGH SCHOOL FOR CLASSROOM SUPPLIES; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID TRANSACTIONS AS PROVIDED FOR BY ARTICLE VI OF THE LAFOURCHE PARISH HOME RULE CHARTER.**

**WHEREAS**, the students and faculty of E.D. White Catholic High School raised \$11,476.00 which was used to purchase gifts and wrapping supplies for the Head Start students and also included a monetary contribution to Head Start faculty of \$6,750.00 to be used for the purchase of classroom supplies of their own choosing; and

**WHEREAS**, this ordinance was sponsored for Administration by Mr. Jerry LaFont, Councilman, District 8; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approve a 2014 Supplemental Appropriation (14-005) within the 2014 Operations and Maintenance Budget to supplement Head Start with a donation from E.D. White Catholic High School for classroom supplies; and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter.

**THEREFORE, BE IT ORDAINED**, by the Lafourche Parish Council, convened in Regular Session on March 11, 2014, and hereby approves a 2014 Supplemental Appropriation (14-005) within the 2014 Operations and Maintenance Budget to supplement Head Start with a donation from E.D. White Catholic High School for classroom supplies; and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter; and

**BE IF FURTHER ORDAINED**, that:

**SECTION 1.** A Supplemental Appropriation of the 2013 Operations and Maintenance Budget is hereby approved as follows:

**FUND 130 - HEAD START FUND**

To purchase classroom supplies:

1. An increase in OTHER REVENUE in the amount of \$6,750
2. An increase in SUPPLIES in the amount of \$6,750

**SECTION 2.** If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

**SECTION 3.** All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

**SECTION 4.** This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

**SECTION 5.** A certified copy of this ordinance shall be forwarded to Lafourche Parish Government: Department of Finance, Department of Community Services, and the Office of the Parish Administrator.

**SECTION 6.** This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
