PROPOSED ORDINANCE

The following Ordinance, having been previously introduced and published, was offered for final adoption by Mr. Lindel Toups, seconded by Mr. John Arnold.

ORDINANCE NO. 5445

AN ORDINANCE TO ESTABLISH THE MAXIMUM SALARIES OF THE MEMBERS OF THE LAFOURCHE PARISH COUNCIL; TO ESTABLISH THE MAXIMUM SALARY OF THE LAFOURCHE PARISH COUNCIL CHAIRMAN; AS WELL AS TO SET A 2% ANNUAL INCREASE EFFECTIVE WITH THE NEXT TERM OF OFFICE, YEAR 2016.

WHEREAS, Article III, Section 5(A), Compensation, of the Lafourche Parish Home Rule Charter, allows the Council to change the annual salaries of the members of the Council by ordinance enacted prior to the last year of their terms of office; and

WHEREAS, this Ordinance therefore establishes the maximum salaries and a 2% annual increase for the members of the Lafourche Parish Council effective with the next term of office, Year 2016, as follows:

- A. Establishing the maximum salary for members of the Lafourche Parish Council at seventeen thousand sixty four dollars and zero cents (\$17,064.00) annually;
- B. Establishing the maximum salary for the Chairman of the Lafourche Parish Council at nineteen thousand two hundred dollars and zero cents (\$19,200.00) annually;
- C. Establishing a 2% annual increase.

BE IT ORDAINED, by the Lafourche Parish Council, which convened in regular session on April 8, 2014, that:

SECTION 1. This Ordinance does hereby establish the maximum salaries of the members of the Lafourche Parish Council, as well as to set a 2% annual increase effective with the next term of office, Year 2016.

SECTION 2. All Ordinances or parts of Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 3. This Ordinance shall be published in the Office Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 4. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
