

The following ordinance was introduced by Mr. Mike Delatte in regular session convened on March 25, 2014.

PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Mike Delatte, seconded by Mr. Jerry Jones.

ORDINANCE NO. 5450

ORDINANCE PROVIDING FOR A 2014 SUPPLEMENTAL APPROPRIATION (14-008) WITHIN THE 2014 OPERATIONS AND MAINTENANCE BUDGET TO COVER THE LAFOURCHE PARISH PROPORTIONAL SHARE OF \$11,819.50 FOR THE METROPOLITAN TRANSPORTATION PLAN (MTP) 2040 PLAN UPDATE; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID TRANSACTIONS AS PROVIDED FOR BY ARTICLE VI OF THE LAFOURCHE PARISH HOME RULE CHARTER.

WHEREAS, the Lafourche Parish proportional share of the \$50,000 local match required by the Federal Highway Administration (FHWA) would total \$11,819.50. The breakdown by Jurisdiction is Assumption \$1,406.04, Napoleonville \$227.78, Lafourche Parish \$11,819.50, Thibodaux \$5,051.01, Lockport \$889.73, and Terrebonne \$30,641.93; and

WHEREAS, the funds will be used to fund our portion of the MTP 2040 Plan Update of the continued development of the LA1 and I-49; and

WHEREAS, this ordinance was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve a 2014 Supplemental Appropriation (14-008) within the 2014 Operations and Maintenance Budget to cover the Lafourche Parish proportional share of \$11,819.50 for the Metropolitan Transportation Plan (MTP) 2040 plan update; and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter.

THEREFORE, BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on April 8, 2014, and hereby approves a 2014 Supplemental Appropriation (14-008) within the 2014 Operations and Maintenance Budget to cover the Lafourche Parish proportional share of \$11,819.50 for the Metropolitan Transportation Plan (MTP) 2040 plan update; and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter; and

BE IF FURTHER ORDAINED, that:

SECTION 1. A Supplemental Appropriation of the 2014 Operations and Maintenance Budget is hereby approved as follows:

FUND 001 GENERAL FUND

To increase budget to cover cost of Metropolitan Transportation Plan (MTP) 2040 Plan Update:

1. An increase in MISCELLANEOUS in the amount of \$11,819.50

SECTION 2. If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

SECTION 3. All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 4. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 5. A certified copy of this ordinance shall be forwarded to Lafourche Parish Government: Department of Finance, Department of Planning & Permitting, Department of Public Works, and the Office of the Parish Administrator.

SECTION 6. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
