PROPOSED ORDINANCE

The following Ordinance, having been previously introduced and published, was offered for final adoption by Mr. Joe Fertitta, seconded by Mr. Jerry LaFont:

ORDINANCE NO. 5458

AN ORDINANCE TO ACCEPT THE SUBDIVISION KNOWN AS THE CRESCENT ESTATES SUBDIVISION PHASE IV-B AND TRACT X-1 INTO THE PARISH SYSTEM.

BE IT ORDAINED, by the Lafourche Parish Council convened in Regular Session on May 13, 2014 that:

SECTION 1. The streets, drainage system, and/or servitudes in the subdivision known as the Crescent Estates Subdivision Phase IV-B and Tract X-1 and being situated in Ward 1, District No. 3 Section 4, T15S, R16E, Lafourche Parish, Louisiana, as shown on the drawings entitled “Crescent Estates Subdivision Phase IV-B and Tract X-1”, sheets 1 through 1 as prepared by CSRS, Taylor M. Gravois, P.L., P.L.S. dated February 25, 2014 are hereby accepted into the Parish system and are to be maintained by the Lafourche Parish Council effective with the completion of the developers’ maintenance obligations as set forth in Section 22-541, Paragraphs (a) (b) (c) of Ordinance No. 3767.

SECTION 2. All Ordinances or parts of Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 3. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 4. This Ordinance having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
