

The following ordinance was introduced by Mr. Jerry Jones in regular session convened on May 13, 2014.

PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Jerry Jones, seconded by Mr. John Arnold.

ORDINANCE NO. 5466

ORDINANCE PROVIDING FOR A 2014 SUPPLEMENTAL APPROPRIATION (14-010) WITHIN THE 2014 OPERATIONS AND MAINTENANCE AND CAPITAL BUDGET TO COVER THE SHORTFALL OF THE PURCHASE OF THE LEGISLATIVE VEHICLE AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID TRANSACTIONS AS PROVIDED FOR BY ARTICLE VI OF THE LAFOURCHE PARISH HOME RULE CHARTER.

WHEREAS, the original budget was \$25,000 and the council is requesting that additional funding be placed in capital outlay to purchase the vehicle at a price of \$26,966.00; and

WHEREAS, the funds will be transferred from the travel line item of the Legislative Department within the General Fund to the Capital Outlay Budget in the amount of \$1,966.00; and

WHEREAS, this ordinance was sponsored for Administration by Mr. Jerry Jones, Councilman, District 1; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the council approve a 2014 Supplemental Appropriation (14-010) within the 2014 Operations and Maintenance and Capital Budget to cover the shortfall of the purchase of the Legislative vehicle and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter.

THEREFORE BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on May 27, 2014, and hereby approves a 2014 Supplemental Appropriation (14-010) within the 2014 Operations and Maintenance and Capital Budget to cover the shortfall of the purchase of the Legislative vehicle and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter; and

BE IF FURTHER ORDAINED, that:

SECTION 1. A Supplemental Appropriation of the 2014 Operations and Maintenance Budget is hereby approved as follows:

FUND 001 GENERAL FUND

To cover the shortfall of Capital Outlay to purchase Legislative Vehicle:

1. A decrease in OTHER SERVICES in the amount of \$1,966.00
2. An increase in MISCELLANEOUS in the amount of \$1,966.00

SECTION 2. A Supplemental Appropriation of the 2014 Capital Budget is hereby approved as follows:

FUND 299 CAPITAL PROJECT FUND

To cover the shortfall of Capital Outlay to purchase Legislative Vehicle:

1. An increase in OTHER REVENUES in the amount of \$1,966.00
2. An increase in CAPITAL OUTLAY in the amount of \$1,966.00

SECTION 3. If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this ordinance which can be given effect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

SECTION 4. All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 5. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 6. A certified copy of this ordinance shall be forwarded to Lafourche Parish Government's Department of Finance and the Office of the Parish Administrator.

SECTION 7. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
