PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Jerry LaFont, seconded by Mr. Lindel Toups.

ORDINANCE NO. 5474

ORDINANCE PROVIDING FOR A 2014 SUPPLEMENTAL APPROPRIATION (14-013) WITHIN THE 2014 OPERATIONS AND MAINTENANCE AND CAPITAL BUDGET TO DE-OBLIGATE RSTD 2 ROAD PROJECTS THAT ARE COMPLETE AND TO DE-OBLIGATE THE DETENTION CENTER BUILDING FUND TO SUPPLEMENT RSTD 2- PHASE 4K PROJECT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID TRANSACTIONS AS PROVIDED FOR BY ARTICLE VI OF THE LAFOURCHE PARISH HOME RULE CHARTER.

WHEREAS, the Detention Center Building Fund (13018) is no longer needed for the building of the jail and there are Road Projects in Road Sales Tax District 2 that are complete; and

WHEREAS, the de-obligation of funds will be used to supplement the Road Sales Tax District 2- Phase 4K project; and

WHEREAS, this ordinance was sponsored for Administration by Mr. Jerry LaFont **Mr. Daniel Lorraine**, Councilman, District 8 **9**; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the council approve a 2014 Supplemental Appropriation (14-013) within the 2014 Operations and Maintenance and Capital Budget to de-obligate RSTD 2 Road Projects that are complete and to de-obligate the Detention Center Building Fund to supplement RSTD 2- Phase 4K Project and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter.

THEREFORE BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on June 10, 2014, and hereby approves a 2014 Supplemental Appropriation (14-013) within the 2014 Operations and Maintenance and Capital Budget to de-obligate RSTD 2 Road Projects that are complete and to de-obligate the Detention Center Building Fund to supplement RSTD 2- Phase 4K Project and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter; and

BE IF FURTHER ORDAINED, that:

If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

SECTION 4. All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 5. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 6. A certified copy of this ordinance shall be forwarded to Lafourche Parish Government Department of Finance, Department of Public Works, and the Office of the Parish Administrator.

SECTION 7. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
