PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Michael Delatte, seconded by Mr. Jerry Jones.

ORDINANCE NO. 5476

ORDINANCE RECOGNIZING THE DEDICATION OF THE TURN AROUND AT THE END OF RUE CHATEAU LOCATED IN GRANDE MAISON SUBDIVISION, INTO THE PARISH SYSTEM.

WHEREAS, by Ordinance 3767; Chapter 22 Land Development, Section 22-539 regarding acceptance of dedication offers; and

WHEREAS, approval of this ordinance will accept the turnaround at the end of Rue Chateau, beginning at the end of the concrete on Rue Chateau measuring eighty (80') feet by twenty (20') feet into the Parish System; and

WHEREAS, this ordinance was sponsored for Council by Michael Delatte, Councilman, District 2; and

NOW, THEREFORE BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on June 10, 2014, that; the turnaround at the end of Rue Chateau located in Grande Maison Subdivision, beginning at the end of the concrete on Rue Chateau measuring eighty (80') feet by twenty (20') feet is hereby added to the Parish System and acknowledging that Grande Maison Subdivision is a public subdivision accepted December 9, 2011 by Ordinance 5037.

BE IT FURTHER ORDAINED, that a certified copy of this Ordinance shall be forwarded to the Lafourche Parish Government Department of Public Works, and the Office of the Parish Administrator and the Planning Department

BE IT FURTHER ORDAINED, that:

SECTION 1. All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 2. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 3. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
