**WHEREAS**, bids were received on April 8, 2014 as follows:

**WHEREAS**, the lowest bid is from Associated Pump & Supply Co. in the amount of \$95,117.00; and

**WHEREAS**, the funding is coming from royalty fund 108, Drainage Project Code# 14023; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council accepts the low bid of Associated Pump & Supply Co. in the amount of \$95,117.00 for the Lafourche Resource Pump Project and authorizes the Parish President to sign, execute and administer any and all relevant documents.
