**RESOLUTION NO. 14-131**

**RESOLUTION REQUESTING THE LAFOURCHE PARISH COUNCIL TO APPROVE THE PURCHASE OF ONE (1) 2014 FORD EXPLORER FROM LAFOURCHE FORD-LINCOLN, LOCKPORT, LOUISIANA IN THE AMOUNT OF \$26,966.00 FOR THE LEGISLATIVE BRANCH OF LAFOURCHE PARISH GOVERNMENT.**

**WHEREAS**, the Legislative Branch of Lafourche Parish Government is requesting approval of the purchase of a vehicle; and

**WHEREAS**, the purchase of this vehicle will be expensed from the 2014 Budget (Capital Outlay); and

**WHEREAS**, three (3) quotes (see attached) were obtained from authorized dealers, with the lowest quote from Lafourche Ford-Lincoln, Lockport, Louisiana in the amount of twenty-six thousand, nine hundred sixty-six dollars and no cents (\$26,966.00); therefore

**BE IT RESOLVED**, by the Lafourche Parish Council, which convened in regular session on May 27, 2014, that it does hereby request the Lafourche Parish Council to approve the purchase of one (1) 2014 Ford Explorer from Lafourche Ford-Lincoln, Lockport, Louisiana in the amount of \$26,966.00 for the Legislative Branch of Lafourche Parish Government.
