RESOLUTION NO. 14-137

A RESOLUTION APPROVING AN AGREEMENT BETWEEN LAFOURCHE PARISH GOVERNMENT AND ALL STAR ELECTRIC, INC. FOR REPAIRS TO THE COTE BLANCHE BRIDGE IN THE AMOUNT OF \$39,136.80 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the Cote Blanche Bridge guard rail and equipment were damaged during a vehicle accident; and

WHEREAS, the repairs to the guard rail and equipment are needed; and

WHEREAS, All Star Electric, Inc. submitted a quote for repairs in the amount of \$39,136.80; and

WHEREAS, the funding will come out of repair and maintenance of bridge; and

WHEREAS, this resolution was sponsored for Administration by Mr. Jerry LaFont, Councilman District 8; and

WHEREAS, it is recommended by the Administration of Lafourche Parish Government that the Council does hereby approve the agreement between Lafourche Parish Government and All Star Electric, Inc. for repairs to the Cote Blanche Bridge in the amount of \$39,136.80 and authorizing the Parish President to sign, execute and administer said agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on May 27, 2014, and does hereby approve agreement between Lafourche Parish Government and All Star Electric, Inc., for repairs to the Cote Blanche Bridge in the amount of \$39,136.80 and authorizing the Parish President to sign, execute and administer said agreement and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to All Star Electric, Inc., 821 Little Farms Ave., Metairie, LA 70003, Attention: Timothy S. Blanchard, President and Arthur E. Westbrook, Jr., Project Manager, Lafourche Parish Government Department of Public Works, Department of Finance, and the Office of the Parish Administrator.
