

On motion by Phillip Gouaux, seconded by John Arnold, the following resolution was introduced and adopted:

**RESOLUTION NO. 14-139**

**RESOLUTION REQUESTING THAT THE LAFOURCHE PARISH COUNCIL APPROVE AND AUTHORIZE LOUISIANA CLAIMS ADMINISTRATION, ON BEHALF OF THE LAFOURCHE PARISH GOVERNMENT, TO SETTLE CLAIM #9978 FOR A TOTAL NOT TO EXCEED FORTY-FIVE THOUSAND DOLLARS (\$45,000.00) AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, on May 7, 2014, an employee of the Lafourche Parish Government caused damages to the property of H.M. Trucking and Jabari Williams; and

**WHEREAS**, Louisiana Claims Administration has estimated the value of the settlement for property and injuries, on behalf of the Lafourche Parish Government, with H.M. Trucking and Jabari Williams, for an amount not to exceed FORTY-FIVE THOUSAND DOLLARS, (\$45,000.00); and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approve and authorize Louisiana Claims Administration, on behalf of the Lafourche Parish Government, to settle Claim #9978 for a total not to exceed forty-five thousand dollars (\$45,000.00) and authorizing the Parish President to sign, execute and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on May 27, 2014, and does hereby approve and authorize Louisiana Claims Administration, on behalf of the Lafourche Parish Government, to settle Claim #9978 for a total not to exceed forty-five thousand dollars (\$45,000.00) and authorizing the Parish President to sign, execute and administer any and all relevant documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to Louisiana Claims Administration at P. O. Box 1246, Prairieville, LA 70769; Lafourche Parish Government Office of Risk Management, Finance Department, and the Office of the Parish Administrator.
