WHEREAS, it is the duty upon oath that the Governing Authority and State Officials address concerns dealing with the general health, safety and welfare of the citizens and said resolution satisfies this criteria: and

WHEREAS, the U.S. Army Corps of Engineers is proposing to construct three (3) mitigation projects in the North Raceland Area; and

WHEREAS, these project would have a detrimental effect on private landowners and the sugar industry in Lafourche Parish; and

WHEREAS, the Lafourche Parish Council does hereby oppose the construction of any mitigation projects in Lafourche Parish that would cause private property to be taken by the State or Federal Government; therefore
