

On motion by Jerry Jones, seconded by Michael Delatte, the following resolution was introduced and adopted;

RESOLUTION NO. 14-148

RESOLUTION APPROVING AMENDMENT NO. 1 TO A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN LAFOURCHE PARISH COUNCIL OFFICE OF COMMUNITY ACTION AND THE STATE OF LOUISIANA DEPARTMENT OF CHILDREN AND FAMILY SERVICES TO PROVIDE ASSISTANCE TO LOW INCOME FAMILIES THROUGH THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP), THE CHILD CARE ASSISTANCE PROGRAM (CCAP), THE FAMILY INDEPENDENCE TEMPORARY ASSISTANCE PROGRAM (FITAP) AND THE KINSHIP CARE SUBSIDY PROGRAM (KCSP); AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID AMENDMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Article VII, Section 14(c) of the Constitution of the State of Louisiana provides that for a public purpose, the State and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation, or individual; and

WHEREAS, an agreement between Lafourche Parish Council Office Community Action and the State of Louisiana Department of Children and Family Services was approved by the Lafourche Parish Council at their meeting of August 9, 2011 under Resolution No. 11-223; and

WHEREAS, it is necessary to amend said agreement to change contact information on Page 5 (Liaison Officials) and Page 6 (Notices) as shown in the attached amendment; and

WHEREAS, this resolution was sponsored for Administration by Mr. Jerry Jones, Councilman, District 1; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves Amendment No. 1 to the Cooperative Endeavor Agreement between Lafourche Parish Council Office of Community Action and the State of Louisiana Department of Children and Family Services to provide assistance to low income families through the Supplemental Nutrition Assistance Program (SNAP), the Child Care Assistance Program (CCAP), the Family Independence Temporary Assistance Program (FITAP), and the Kinship Care Subsidy Program (KCSP) and authorizes the Parish President to sign, execute, and administer said amendment and any and all relevant documents.

THEREFORE BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on June 10, 2014, and does hereby approve Amendment No. 1 to the Cooperative Endeavor Agreement between Lafourche Parish Council Office of Community Action and the State of Louisiana Department of Children and Family Services to provide assistance to low income families through the Supplemental Nutrition Assistance Program (SNAP), the Child Care Assistance Program (CCAP), the Family Independence Temporary Assistance Program (FITAP), and the Kinship Care Subsidy Program

(KCSP); and authorizes the Parish President to sign, execute, and administer said amendment and any and all relevant documents.
