RESOLUTION NO. 14-149

RESOLUTION APPROVING AN AGREEMENT BETWEEN SECOND HARVEST FOOD BANK OF GREATER NEW ORLEANS AND ACADIANA AND LAFOURCHE PARISH COUNCIL OFFICE OF COMMUNITY ACTION TO OPERATE DISTRIBUTION OF COMMODITIES THROUGH A MOBILE PANTRY AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Second Harvest of Greater New Orleans and Acadiana offers programs to implement distribution of commodities made available by the United States Department of Agriculture to eligible soup kitchens, food banks, food pantries, and emergency feeding organizations; and

WHEREAS, this program services the Lafourche Parish area by providing commodities for low-income households in Lafourche Parish; and

WHEREAS, this resolution was sponsored for Administration by Mr. Jerry Jones, Councilman, District 1; and

WHEREAS, it is recommended by the Administration of Lafourche Parish Government that the Council approve an agreement between Second Harvest Food Bank of Greater New Orleans and Acadiana and Lafourche Parish Council Office of Community Action to operate distribution of commodities through a mobile pantry and authorizing the Parish President to sign, execute and administer said agreement and any and all relevant documents; and

THEREFORE BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on June 10, 2014, and does hereby approve an agreement between Second Harvest Food Bank of Greater New Orleans and Acadiana and Lafourche Parish Council Office of Community Action to operate distribution of commodities through a mobile pantry and authorizing the Parish President to sign, execute and administer said agreement and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Second Harvest Food Bank, 700 Edwards Avenue, New Orleans, LA 70123; Lafourche Parish Community Services; Lafourche Parish Community Action; and the Office of the Parish Administrator.
