

On motion by Jerry LaFont, seconded by Joe Fertitta, the following resolution was introduced and adopted:

RESOLUTION NO. 14-150

RESOLUTION APPROVING CHANGE ORDER NO. 3 FOR THE PROJECT ENTITLED DRAINAGE IMPROVEMENTS NEAR WEST 111TH & EAST 86TH STREETS, INCREASING THE CONTRACT PRICE BY \$42,536.00 AND INCREASING THE CONTRACT TIME BY 10 CALENDAR DAYS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Change Order No. 3 is being presented to extend storm sewers to replace an existing ditch in the area of East 86th Street; and

WHEREAS, a total of 370 feet of new 36-inch diameter storm sewers would extend along the existing ditch line to West Avenue B; and

WHEREAS, the contract price will be increased by \$42,536.00 for a revised total of \$436,522.00; and

WHEREAS, 10 calendar days will be added to the contract time, so that the new completion date will be August 8, 2014; and

WHEREAS, this Resolution was sponsored for Administration by Mr. Jerry LaFont Councilman, District 8; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves Change Order No. 3 for the project entitled Drainage Improvements near West 111th & East 86th Streets increasing the contract price by \$42,536.00 and increasing the contract time by 10 calendar days and authorizing the Parish President to sign, execute and administer said change order and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on June 10, 2014, and does hereby approve Change Order No. 3 for the project entitled Drainage Improvements near West 111th & East 86th Streets increasing the contract price by \$42,536.00 and increasing the contract time by 10 calendar days and authorizing the Parish President to sign, execute and administer said change order and any and all relevant documents.
