RESOLUTION NO. 14-151

RESOLUTION APPROVING A GRANT BETWEEN THE LOUISIANA WORKFORCE COMMISSION (LWC) AND LAFOURCHE PARISH COUNCIL (LOCAL GRANT RECIPIENT) WITH THE FISCAL AGENT BEING LAT WORKFORCE INVESTMENT BOARD, INC. FOR PROGRAM YEAR BEGINNING APRIL 1, 2014 AND ENDING JUNE 30, 2016 TO RECEIVE FUNDING FROM THE LOUISIANA WORKFORCE COMMISSION TO PROVIDE SERVICES TO YOUTH, ADULT, AND DISLOCATED WORKERS IN THE REGION AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID GRANT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, this grant is to receive funding from the Louisiana Workforce Commission (LWC) to provide services for youth, adult, and dislocated workers in the region; and

WHEREAS, this grant covers the period from April 1, 2014 through June 30, 2016; and

WHEREAS, in consideration of the services described in this grant (attached), the LWC hereby agrees to pay Lafourche Parish Council (Local Grant Recipient) a maximum fee of \$768,450.00; and

WHEREAS, Lafourche Parish Council (Local Grant Recipient) shall provide workforce development services in accordance with Title I-B of the Workforce Investment Action (Public Law 105-220-August 7, 1998) and the Local and Regional Workforce Investment Area Plans; and

WHEREAS, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council hereby approve a grant between the Louisiana Workforce Commission (LWC) and the Lafourche Parish Council (Local Grant Recipient) with the fiscal agent being LAT Workforce Investment Board, Inc. for the program year beginning April 1, 2014 and ending June 30, 2016 to receive funding from the Louisiana Workforce Commission to provide services to youth, adult, and dislocated workers in the region and authorizing the Parish President to sign, execute, and administer said grant and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council, convened in regular session on June 10, 2014, and does hereby approve a grant between the Louisiana Workforce Commission (LWC) and Lafourche Parish Council (Local Grant Recipient) with the fiscal agent being LAT Workforce Investment Board, Inc. for the program year beginning April 1, 2014 and ending June 30, 2016 to receive funding from the Louisiana Workforce Commission to provide services to youth, adult, and dislocated workers in the region and does hereby authorize the Parish President to sign, execute, and administer said grant and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to LAT Workforce Investment Board, Inc., P.O. Box 4115, Houma, LA 70361; Lafourche Parish Department of Community Services; Lafourche Parish Finance Department; and the Office of the Parish Administrator.
