**RESOLUTION NO. 14-154**

**RESOLUTION APPROVING AN AGREEMENT BETWEEN LAFOURCHE PARISH GOVERNMENT AND OPTIONS FOR INDEPENDENCE TO PROVIDE SERVICES TO THE REVEREND LLOYD WALLACE COMMUNITY CENTER AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Options for Independence's services include support for a wide variety of needs through well-organized programs; and

**WHEREAS**, Options for Independence will staff the Center, utilizing several part-time staff members who would rotate times at the Center; and

**WHEREAS**, all Center staff would be monitored and supervised by the program director; and

**WHEREAS**, said contract would commence on June 11, 2014 and terminate on June 30, 2014; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves an agreement between Lafourche Parish Government and Options for Independence to provide services to the Reverend Lloyd Wallace Community Center and authorizing the Parish President to sign, execute and administer said agreement and any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on June 10, 2014, approves a contract between Lafourche Parish Government and Options for Independence to provide services to the Reverend Lloyd Wallace Community Center and authorizing the Parish President to sign, execute and administer said agreement and any and all relevant documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to Options for Independence, 1340 W. Tunnel Blvd., Houma, LA 70360; Lafourche Parish Dept. of Community Services; Lafourche Parish Finance Dept; and the Office of the Parish Administrator.
