ORDINANCE NO. 5455

ORDINANCE AMENDING ORDINANCE NO. 4894 AS IT PERTAINS TO CHANGING THE NAME OF THE SUBDIVISION FORMALLY KNOWN AND ACCEPTED INTO THE PARISH SYSTEM AS WAVERLY ESTATES AND RENAMING IT CYPRESS POINT AT WAVERLY.

BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on May 13, 2014, that:

WHEREAS, Ordinance No. 4894 is hereby amended to read as follows:

SECTION 1. Said Ordinance formally accepted, March 25, 2011, into the Parish System as Waverly Estates be changed in name only to Cypress Point At Waverly.

SECTION 2. If any section, clause, paragraph, provision or portion of these regulations shall be held invalid by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of these regulations.

SECTION 3. All Ordinances or parts of Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 4. This Ordinance shall be published in the Office Journal of the Lafourche Parish Council in the manner provided by law.
