

**THIS ORDINANCE WAS RESCINDED BY ORDINANCE NO. 5743 AT  
THE FEBRUARY 23, 2016 LPC REGULAR MEETING.**

The following ordinance was introduced by Mr. Daniel Lorraine in regular session convened on July 22, 2014.

**PROPOSED ORDINANCE**

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Jerry LaFont, seconded by Mr. Michael Delatte.

**ORDINANCE NO. 5510**

**ORDINANCE APPROVING A LEASE AGREEMENT BETWEEN LAFOURCHE PARISH GOVERNMENT AND BAYOU CIVIC CLUB, INC. FOR USE OF THE LAROSE CIVIC CENTER FOR LAFOURCHE PARISH'S SUMMER RECREATION PROGRAM AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID LEASE AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Lafourche Parish Government is in need of a facility to utilize for summer recreation programs in the South Lafourche area; and

**WHEREAS**, Bayou Civic Club, Inc. is willing to lease the Larose Civic Center to Lafourche Parish Government for six weeks each year from June to July commencing in 2014 and ending in 2029 as agreed upon in the attached lease agreement; and

**WHEREAS**, Lafourche Parish Government will pay a rental fee to Bayou Civic Club, Inc. in the amount of \$3,369.55 in 2014 for said facility; and

**WHEREAS**, each year said rental rate will automatically increase by 3%; and

**WHEREAS**, upon approval, said lease agreement shall supersede the prior lease agreement with Bayou Civic Club, Inc. for summer recreation programs and therefore said lease agreement entered into on May 15, 2013 under Resolution No. 13-160 is hereby void; and

**WHEREAS**, this ordinance was sponsored for Administration by Mr. Jerry LaFont, Councilman, District 8; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves a Lease Agreement between Lafourche Parish Government and Bayou Civic Club, Inc. for use of the Larose Civic Center for Lafourche Parish's summer recreation program and authorizing the Parish President to sign, execute and administer said lease agreement and any and all relevant documents.

**THEREFORE BE IT ORDAINED**, that the Lafourche Parish Council convened in Regular Session on August 12, 2014, and hereby approves a Lease Agreement between Lafourche Parish Government and Bayou Civic Club, Inc. for use of the Larose Civic Center for Lafourche Parish's summer recreation program and authorizing the Parish President to sign, execute and administer said lease agreement and any and all relevant documents.

**BE IT FURTHER ORDAINED**, that a certified copy of this Ordinance shall be forwarded to the Bayou Civic Club, Inc, attn: Ms. Jasmine Ayo, Executive Director, PO Box 1105, Larose, LA 70373; Lafourche Parish Government Department of Community Services; Department of Finance, Office of Risk Management, and the Office of the Parish Administrator.

**BE IT FURTHER ORDAINED**, that;

**SECTION 1.** If any provision or item of this Ordinance or the application thereof is held invalid, such invalidity shall not effect other provisions, items or application of this Ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions

of this Ordinance are declared severable.

**SECTION 2.** All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

**SECTION 3.** This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

**SECTION 4.** This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
