### **PROPOSED ORDINANCE**

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Joe Fertitta, seconded by Mr. Lindel Toups.

### **ORDINANCE NO. 5533**

#### **AN ORDINANCE TO RESCIND ORDINANCE NO. 5490 AS IT PERTAINS TO ROLLING FORWARD OF LEVYING AND IMPOSING TAXES FOR 2014 ON ALL THE PROPERTY SUBJECT TO TAXATION IN THE PARISH OF LAFOURCHE (COUNCIL ON AGING).**

**WHEREAS**, Ordinance No. 5490 was presented before the Lafourche Parish Council on August 12, 2014 to roll forward the 2014 millage for Council on Aging at an adjusted maximum rate of 2.000; and

**WHEREAS**, The Louisiana Legislative Auditor's Office rejected the ordinance due to insufficient documentation presented for rolling forward the millage; and

**WHEREAS**, the deadline to roll forward the millage for Council on Aging has expired for 2014; therefore, Council on Aging will have to resubmit to roll forward their mill for the year 2015; and

**WHEREAS**, this ordinance was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council hereby rescind Ordinance No. 5490 as it pertains to rolling forward of levying and imposing taxes for 2014 for Council on Aging due to insufficient documentation presented for rolling forward the millage for 2014; and

**NOW, THEREFORE BE IT ORDAINED**, by the Lafourche Parish Council, convened in Regular Session on September 23, 2014, and does hereby rescind Ordinance No. 5490 as it pertains to rolling forward of levying and imposing taxes for 2014 for Council on Aging due to insufficient documentation presented for rolling forward the millage for 2014.

**BE IT FURTHER ORDAINED**, that;

**SECTION 1.** If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

**SECTION 2.** All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

**SECTION 3.** This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

**SECTION 4.** A certified copy of this ordinance shall be forwarded to Lafourche Parish Government's Department of Finance and the Office of the Parish Administrator.

**SECTION 5.** This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
