**WHEREAS**, according to the Lafourche Parish Government's records, Mr. Jacob Giardina's and Dr. Obie Cleveland Hill's terms expired on June 9, 2014; and

**WHEREAS**, these positions were advertised and two (2) applications were received; and

**WHEREAS**, Dr. Obie Cleveland Hill and Mr. Jacob Giardina have submitted their applications to fill two (2) positions; and

**WHEREAS**, this resolution was sponsored for administration by Mr. Michael Delatte, District 2; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this application.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on June 24, 2014, and does hereby appoint Dr. Obie Cleveland Hill and Mr. Jacob Giardina to the Hospital Service District No. 3 Board to serve a six (6) year term beginning June 24, 2014, and ending June 23, 2020.
