**RESOLUTION REQUESTING THE LAFOURCHE PARISH COUNCIL TO APPROVE AND AUTHORIZE JOSHUA COCKFIELD, THIRD PARTY ADMINISTRATOR, TO SETTLE WORKERS' COMPENSATION CLAIM # LCA - 0007396 FOR \$ 135,000.00 ON BEHALF OF THE LAFOURCHE PARISH GOVERNMENT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Joshua Cockfield, Owner/Claims Manager, is the Lafourche Parish Government's Third Party Administrator; and

**WHEREAS**, on or about November 11, 2011 employee suffered a personal injury by accident which occurred in the course of and arose out of his/her employment; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approve and authorize Joshua Cockfield, Third Party Administrator, to settle Workers' Compensation Claim # LCA- 0007396 for \$ 135,000.00 on behalf of the Lafourche Parish Government and authorizing the Parish President to sign, execute and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on July 8, 2014 and does hereby approve and authorize Joshua Cockfield, Third Party Administrator, to settle Workers' Compensation Claim # LCA-0007396 for \$ 135,000.00 on behalf of the Lafourche Parish Government and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
