RESOLUTION NO. 14-181

RESOLUTION ACCEPTING THE LOW BID OF JAMES BOURGEOIS CONTRACTOR, INC., IN THE AMOUNT OF NINE THOUSAND SEVEN HUNDRED NINETY DOLLARS (\$9,790.00) FOR CONTRACTOR SERVICES RELATED TO NUISANCE ABATEMENT ORDINANCE NUMBERS 3895 AND 4944 CONCERNING THE DEMOLITION OF A CONDEMNED STRUCTURE LOCATED AT 24340 HWY 1, LEEVILLE, LA 70357, ASSESSMENT #0102181200, AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, pursuant to the Nuisance Abatement Ordinance Numbers 3895 and 4944 Lafourche Parish Government is authorized to take corrective action in the event that property owner fails or refuses to comply with provisions of said ordinance; and

WHEREAS, the Lafourche Parish Government requires the use of a parish contractor to provide demolition services to remedy such violations; and

WHEREAS, it is necessary to acquire contractor services to implement the remediation and abatement of nuisance properties as authorized by said ordinances; and

WHEREAS, bids were received for said contractor services as follows:

WHEREAS, the low bidder is James Bourgeois Contractor, Inc., in the amount of \$9,790.00; and

WHEREAS, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council accept the low bid of James Bourgeois Contractor, Inc., in the amount of nine thousand seven hundred ninety dollars (\$9,790.00) for contractor services related to Nuisance Abatement Ordinance Numbers 3895 and 4944 concerning the demolition of a condemned structure located at 24340 Hwy 1, Leeville, LA 70357, Assessment #0102181200, and authorizes the Parish President to sign, execute, and administer said contract and any and all relevant documents.
