

On motion by Michael Delatte, seconded by Aaron Caillouet, the following resolution was introduced and adopted:

RESOLUTION NO. 14-183

RESOLUTION APPROVING CHANGE ORDER NO. 2 FOR THE PROJECT ENTITLED “2013 ROAD SALES TAX DISTRICT A IMPROVEMENTS”, INCREASING THE CONTRACT PRICE BY \$169,061.50 AND INCREASING THE CONTRACT TIME BY 14 CALENDAR DAYS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, said Change Order is being presented to include multiple streets and improvements to the contract; and

WHEREAS, said Change Order is necessary to increase the total amount of the Contract by \$169,061.50 for a new contract price totaling \$2,975,014.98; and

WHEREAS, the contract time will increase by 14 calendar days for a new completion date of November 18, 2014; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte Councilman, District 2; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves Change Order No. 2 for the project entitled “2013 Road Sales Tax District A Improvements”, increasing the contract price by \$169,061.50 and increasing the contract time by 14 calendar days and authorizing the Parish President to sign, execute and administer said change order and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on July 8, 2014, and does hereby approve Change Order No. 2 for the project entitled “2013 Road Sales Tax District A Improvements”, which increases the contract price by \$169,061.50 and increases the contract time by 14 calendar days and authorizing the Parish President to sign, execute and administer said change order and any and all relevant documents.
