WHEREAS, the South Lafourche Beachfront Development District currently has one (1) vacancy which occurred from the expired term of Mr. Rickey Cheramie; and

WHEREAS, the vacancy is the appointment of Councilmatic District 9; and

WHEREAS, Mr. Rickey Cheramie is being nominated to represent Councilmatic District 9:
and
