

On motion by Michael Delatte, seconded by Lindel Toups, the following resolution was introduced and adopted;

RESOLUTION NO. 14-188

RESOLUTION APPROVING A CONTRACT WITH PREMIER CATERING & EVENTS (PCE) TO PROVIDE ALL CATERING SERVICES NECESSARY TO SUPPORT EMERGENCY OPERATIONS TO THE LOCATIONS IDENTIFIED BY THE LAFOURCHE PARISH GOVERNMENT EMERGENCY OPERATIONS CENTER (CLIENT) AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Premier Catering & Events has offered the Lafourche Parish Government a contract to provide food services in emergency situations; and

WHEREAS, the food services will consist of three (3) meals per day; breakfast, lunch and dinner including a midnight boxed meal that is available on demand at no additional cost; and

WHEREAS, considering all emergency situations are different, there are different food plans as shown in the attached contract; and

WHEREAS, the term of this contract will commence on the date of execution and terminate on December 31, 2015; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the contract with Premier Catering & Events (PCE) to provide all catering services necessary to support emergency operations to the locations identified by the Lafourche Parish Government Emergency Operations Center (Client) and authorizes the Parish President to sign, execute and administer said contract and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on July 8, 2014, and does hereby approve the contract with Premier Catering & Events (PCE) to provide all catering services necessary to support emergency operations to the locations identified by the Lafourche Parish Government Emergency Operations Center (Client) and authorizes the Parish President to sign, execute and administer said contract and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Premier Catering & Events, 1600 Ridgefield Road, Thibodaux, LA 70301; Lafourche Parish Government Office of Emergency Preparedness, Department of Finance, Office of Risk Management, and the Office of the Parish Administrator.
