**RESOLUTION NO. 14-204**

**RESOLUTION APPROVING THE LOW BID OF ZEE CONSULTING, LLC FOR THE CHOCTAW FIRE STATION BANK STABILIZATION IN THE AMOUNT OF \$151,452.00 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, the bank along the Choctaw Fire Department property needs to be stabilized to protect an existing Fire Department building; and

**WHEREAS**, (5) five bids were received as listed below with Zee Consulting, LLC, having the lowest bid:

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approve the low bid of Zee Consulting, LLC for the Choctaw Fire Department Bank Stabilization in the amount of \$151,452.00 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
