RESOLUTION NO. 14-210

RESOLUTION ACCEPTING THE LOW BID OF M&L ENGINE, LLC IN THE AMOUNT OF \$183,829.00 FOR THE PURCHASE OF TWO PORTABLE PUMPS AND ASSOCIATED EQUIPMENT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, a Bid Document was issued for public bids for a 24-inch hydraulic pump, a 30-inch hydraulic pump and associated equipment; and

WHEREAS, three (3) bids were received as follows:

M&L Engine:	\$183,829.00
Associated Pump:	\$192,851.00
Infinity Pump:	\$225,878.00

WHEREAS, the lowest bid was received by M&L Engine, LLC in the amount of \$183,829.00; and

WHEREAS, the funding will come from RSTD-A; and

WHEREAS, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council accepts the low bid of M&L Engine, LLC in the amount of \$183,829.00 for the purchase of two portable pumps and associated equipment and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on August 12, 2014, and does hereby accept the low bid of M&L Engine, LLC in the amount of \$183,829.00 for the purchase of two portable pumps and associated equipment and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to the Lafourche Parish Government Department of Public Works, Department of Finance, and the Office of the Parish Administrator.
