RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO REPRESENT THE TOWN OF GOLDEN MEADOW ON THE LAFOURCHE PARISH FIRE PROTECTION DISTRICT NO. 3 BOARD.

WHEREAS, Mr. Morris Guidry serves on the Lafourche Parish Fire Protection District No. 3 Board and represents the Town of Golden Meadow; and

WHEREAS, according the Lafourche Parish Government's records, Mr. Guidry's term expired on July 26, 2014; and

WHEREAS, a resolution from the Town of Golden Meadow recommends Mr. Guidry be reappointed to the Lafourche Parish Fire Protection District No. 3 Board; and

WHEREAS, this resolution was sponsored for administration by Mr. Daniel Lorraine, District 9 and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.
