**RESOLUTION NO. 14-218**

**RESOLUTION APPROVING AN INTERAGENCY AGREEMENT BETWEEN LAFOURCHE PARISH COUNCIL HEAD START AND THE LAFOURCHE PARISH SCHOOL BOARD TO COORDINATE EFFORTS FOR THE 2014-15 SCHOOL YEAR TO IDENTIFY AND SERVE CHILDREN WHO ARE AT RISK FOR DEVELOPMENTAL DELAYS AND/OR HAVE EXCEPTIONAL NEEDS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, this agreement is to clarify the roles and responsibilities of the LEA and Head Start in the processes of referral, evaluation, delivery of services, and transition for Part B eligible children with disabilities; and

**WHEREAS**, this agreement is consistent with Bulletin 1706-Regulations for Implementation of the Exceptional Children's Act, Bulletin 1530-Pupil Appraisal Handbook, and Head Start Program Performance Standards; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Jerry LaFont, Councilman, District 8; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the Interagency Agreement between Lafourche Parish Council Head Start and the Lafourche Parish School Board to coordinate efforts for the 2014-15 school year to identify and serve children who are at risk for developmental delays and/or have exceptional needs and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on August 12, 2014 and does hereby approve the Interagency Agreement between Lafourche Parish Council Head Start and the Lafourche Parish School Board to coordinate efforts for the 2014-15 school year to identify and serve children who are at risk for developmental delays and/or have exceptional needs and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to Pupil Appraisal Center, 110 Bowie Road Thibodaux, Louisiana 70301; Lafourche Parish Government Department of Head Start, and the Office of the Parish Administrator.
