IN THE AMOUNT OF \$24,961.00 FOR THE PROJECT ENTITLED “REROOFING OF THE LAFOURCHE PARISH LIBRARY, THIBODAU BRANCH” AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER AN AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the Lafourche Parish Library roof is in need of repairs; and

WHEREAS, three (3) quotes were requested and received as follows:

WHEREAS, although CAMCO submitted the lowest quote, Duplantis Design Group, PC is hesitant to award the additional work to them due to numerous problems encountered with the original work, repeated leaks, their reluctance to accept responsibility for the leaks, and overall poor communication with their project manager; and

WHEREAS, it is recommended by Duplantis Design Group, PC and this Administration that the quote of Edward J. Laperouse Metal Works, Inc. in the amount of \$24,961.00 be accepted; and

WHEREAS, the funding will come out of the Library Fund; and

WHEREAS, this resolution was sponsored for Administration by Mr. John Arnold, Councilman, District 5; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the low quote of Edward J. Laperouse Metal Works, Inc. in the amount of \$24,961.00 for the project entitled “Reroofing of the Lafourche Parish Library, Thibodaux Branch” and authorizes the Parish President to sign, execute and administer an agreement and any and all relevant documents.
