RESOLUTION NO. 14-224

RESOLUTION SUPPORTING REPRESENTATIVE JERRY “TRUCK” GISCLAIR’S REQUEST TO DOTD TO INSTALL A FULL TRAFFIC SIGNAL AT LA HIGHWAY 3161 AND HIGHWAY 3235 INTERSECTION IN AN ATTEMPT TO AVOID ANY POSSIBLE FUTURE ACCIDENTS AND/OR FATALITIES.

WHEREAS, it is the duty upon oath that the Governing Authority and State Officials address concerns dealing with the general health, safety and welfare of the citizens and said resolution satisfies this criteria; and

WHEREAS, there have been many accidents and fatalities at the intersection of LA Highway 3161 and Highway 3235; and

WHEREAS, Representative Jerry “Truck” Gisclair has made numerous requests to DOTD to add traffic regulations to this intersection such as a full traffic signal in an attempt to avoid any possible future accidents and/or fatalities.

BE IT RESOLVED, by the Lafourche Parish Council, which convened in regular session on August 26, 2014, that it does hereby support Representative Jerry “Truck” Gisclair’s request to DOTD to install a full traffic signal at LA Highway 3161 and Highway 3235 intersection in an attempt to avoid any possible future accidents and/or fatalities.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Mr. Dennis Hebert, LADOTD; Mr. Lyle LeBlanc, DOTD; the Lafourche Parish Legislative Delegation and the Office of the Parish Administrator.
