RESOLUTION ACCEPTING THE LOW BID OF LEE TRACTOR COMPANY, INC. IN THE AMOUNT OF \$112,455.00 FOR THE PURCHASE OF A NEW CRAWLER DOZER AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, a bid document was issued for public bids for a new crawler dozer; and

WHEREAS, four (4) bids were received as follows:

Lee Tractor Company, Inc:	\$112,455.00
CLM Equipment Company:	\$116,488.00
Louisiana Machinery:	\$120,942.00
Doggett Machinery Services:	\$138,910.00

WHEREAS, the lowest bid was received by Lee Tractor Company in the amount of \$112,455.00; and

WHEREAS, the funding will come from RSTD-A; and

WHEREAS, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council accepts the low bid of Lee Tractor Company, Inc. in the amount of \$112,455.00 for the purchase of a new crawler dozer and authorizes the Parish President to sign, execute and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on August 26, 2014, and does hereby accept the low bid of Lee Tractor Company, Inc. in the amount of \$112,455.00 for the purchase of a new crawler dozer and authorizes the Parish President to sign, execute and administer any and all relevant documents.
