RESOLUTION NO. 14-232

RESOLUTION APPROVING A CONTRACT BETWEEN THE DIVISION OF ADMINISTRATION AND LAFOURCHE PARISH GOVERNMENT FOR REPAIRS TO THE RITA STREET BRIDGE IN LOCKPORT, LOUISIANA UNDER THE LOUISIANA GOVERNMENT ASSISTANCE PROGRAM AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the purpose of the Louisiana Local Government Assistance Program from the Louisiana Office of Community Development is to assist units of local government with funding for needed infrastructure and long term capital improvements; and

WHEREAS, the Lafourche Parish Government is responsible for providing, maintaining, and improving public infrastructure; and

WHEREAS, the Louisiana Office of Community Development has approved the Louisiana Local Government Assistance Grant Application submitted by Lafourche Parish Government and awarded a contract up to \$39,800.00 to make repairs to the Rita Street Bridge in Lockport, Louisiana and issued a contract by and between the Division of Administration and the Lafourche Parish Government; and

WHEREAS, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve a contract between the Division of Administration and Lafourche Parish Government for repairs to the Rita Street Bridge in Lockport, Louisiana under the Louisiana Local Government Assistant Program and authorizes the Parish President to sign, execute and administer said contract and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on August 26, 2014 and does hereby approve a contract between the Division of Administration and Lafourche Parish Government for repairs to the Rita Street Bridge in Lockport, Louisiana under the Louisiana Local Government Assistant Program and authorizes the Parish President to sign, execute and administer said contract and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to the Office of Community Development, P.O. Box 94095, Baton Rouge, LA 70804-9095; Lafourche Parish Government Department of Grants & Economic Development, Department of Public Works, Department of Finance, and the Office of the Parish Administrator.
