RESOLUTION NO. 14-233

RESOLUTION APPROVING THE LOW QUOTE OF SEALEVEL CONSTRUCTION, INC. IN THE AMOUNT OF \$80,636.00 FOR REPLACEMENT OF CULVERTS UNDER THE 40 ARPENT ROAD AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER AN AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the existing culvert under the 40 Arpent Road is undersized and is contributing to flooding in the Abby Lakes Subdivision; and

WHEREAS, three (3) quotes were requested and received as follows:

1.	Sealevel Construction, Inc.	\$80,636.00
2.	Low Land Construction Co., Inc.	\$90,075.66
3.	LA Contracting Enterprises LLC	\$92,940.00

WHEREAS, Sealevel Construction, Inc. has the lowest quote in the amount of \$80,636.00; and

WHEREAS, funding will come from the Capital Project Drainage Improvement Fund, Project Code # 13048; and

WHEREAS, this resolution was sponsored for Administration by Mr. Jerry Jones, Councilman, District 1; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve the low quote of Sealevel Construction, Inc. in the amount of \$80,636.00 for the replacement of culverts under the 40 Arpent Road and authorizes the Parish President to sign, execute, and administer an agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on August 26, 2014, and does hereby approve the low quote of Sealevel Construction, Inc., in the amount of \$80,636.00 for the replacement of culverts under the 40 Arpent Road and authorizes the Parish President to sign, execute, and administer an agreement and any and all relevant documents.
