RESOLUTION NO. 14-239

RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) TO ADDRESS THE DIFFERENCE IN THE HEIGHT OF THE SHOULDER IN RELATION TO THE HEIGHT OF THE HIGHWAY ON HIGHWAY 308 THROUGHOUT THE PARISH AND TO CORRECT THIS PROBLEM IMMEDIATELY DUE TO THE NUMEROUS ACCIDENTS AND FATALITIES.

WHEREAS, the Lafourche Parish Council has made and continues to make requests to the Louisiana Department of Transportation and Development which concerns the general health, safety and welfare of the citizens of the Parish; and

WHEREAS, it is the duty upon oath that the Governing Authority and State Officials address concerns dealing with the general health, safety and welfare of the citizens and said resolution satisfies this criteria; and

WHEREAS, there have been many accidents and fatalities on Highway 308 due to the condition of the shoulder to the road being a difference in height on Hwy 308; therefore

BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on September 9, 2014, that it does hereby request the Louisiana Department of Transportation and Development (LADOTD) to address the difference in the height of the shoulder in relation to the height of the highway on Highway 308 throughout the Parish and to correct this problem immediately due to the numerous accidents and fatalities.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to the Louisiana Department of Transportation and Development; the Legislative Delegation and the Office of the Parish Administrator.
