**RESOLUTION NO. 14-244**

**RESOLUTION APPROVING A NEW GRANT CONTRACT WITH THE LOUISIANA OFFICE OF COMMUNITY DEVELOPMENT FOR CONTINUATION OF PROGRAM ACTIVITIES IN CONNECTION WITH THE REVEREND LLOYD WALLACE COMMUNITY CENTER AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Lafourche Parish Government received a Louisiana Community Development Grant Contract No. 698947 from the Division of Administration, Office of Community Development for construction of the Reverend Lloyd Wallace Community Center; and

**WHEREAS**, the Division of Administration contract expired on December 13, 2013, and there remains outstanding invoices for which the Parish could be reimbursed, totaling \$1,225.00; and

**WHEREAS**, the Division of Administration has issued a new grant agreement in order to provide continuation of program activities and to extend the completion date to December 13, 2016; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approve a new grant contract with the Louisiana Office of Community Development for continuation of program activities in connection with the Reverend Lloyd Wallace Community Center and authorizes the Parish President to sign, execute and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on September 9, 2014, and does hereby approve a new grant contract with the Louisiana Office of Community Development for continuation of program activities in connection with the Reverend Lloyd Wallace Community Center and authorizes the Parish President to sign execute, and administer any and all relevant documents.
