

On motion by Jerry LaFont, seconded by Joe Fertitta, the following resolution was introduced and adopted;

**RESOLUTION NO. 14-255**

**RESOLUTION APPROVING A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN LAFOURCHE PARISH GOVERNMENT AND BAYOU CIVIC CLUB, INC. TO PROVIDE FUNDING FOR REPAIRS TO THE BUILDING AND AIR CONDITIONERS AT THE BAYOU CIVIC CLUB; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Bayou Civic Club, Inc. provides recreational activities to children and adults; and

**WHEREAS**, Lafourche Parish Government budgeted one hundred fifty thousand dollars (\$150,000.00) to provide to Bayou Civic Club, Inc.; and

**WHEREAS**, said funding shall be used to provide funding for repairs to the building and air conditioners at the Bayou Civic Club for the residents to utilize; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Jerry LaFont, Councilman, District 8; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approve the Cooperative Endeavor Agreement between Lafourche Parish Government and Bayou Civic Club, Inc. to provide funding for repairs to the building and air conditioners at the Bayou Civic Club and authorize the Parish President to sign, execute, and administer said agreement and any and all relevant documents.

**NOW, THEREFORE, BE IT RESOLVED**, by Lafourche Parish Council, convened in regular session on September 9, 2014, and does hereby approve the Cooperative Endeavor Agreement between Lafourche Parish Government and Bayou Civic Club, Inc. to provide funding for repairs to the building and air conditioners at the Bayou Civic Club and authorize the Parish President to sign, execute, and administer said agreement and any and all relevant documents.
