RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) TO INSTALL “BEWARE OF CYCLISTS” SIGNS ON HWY. 652 AND HWY. 653 IN RACELAND, LOUISIANA DUE TO THE NUMEROUS ACCIDENTS WHICH HAVE OCCURRED.

WHEREAS, the Lafourche Parish Council has made and continues to make requests to the Louisiana Department of Transportation and Development which concerns the general health, safety and welfare of the citizens of the Parish; and

WHEREAS, it is the duty upon oath that the Governing Authority and State Officials address concerns dealing with the general health, safety and welfare of the citizens and said resolution satisfies this criteria; and

BE IT RESOLVED, by the Lafourche Parish Council, which convened in regular session on September 9, 2014, that it does hereby request the Louisiana Department of Transportation and Development (LADOTD) to install “Beware of Cyclists” signs on Hwy. 652 and Hwy. 653 in Raceland, Louisiana due to the numerous accidents which have occurred.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to the Louisiana Department of Transportation and Development, the Legislative Delegation and the Office of the Parish Administrator.
